## Purpose of the Policy

The purpose of this policy is to establish the criteria for coverage of Elelyso.

## Statement of the Policy

Health Alliance Medical Plans will approve the use of Elelyso under the Specialty Medical benefit when the following criteria have been met.

## Criteria

### 1. Coverage Criteria for the Treatment of Gaucher disease

- 1.1 Diagnosis of type 1 Gaucher disease confirmed by genetic testing or enzyme assay
- 1.2 Age 4 years or older
- 1.3 Prescribed by a Geneticist (gene specialist)

### 2. Exclusion Criteria

- 2.1 Not used in combination with Zavesca, Cerdelga, Cerezyme or VPRIV

### 3. Approval Period

- 3.1 Initial: 12 months
- 3.2 Reauthorization: 12 months with documented clinical benefit from therapy
