| Star Measure Description |
| This measure shows the percent of plan members whose medication records were updated within 30 days after leaving the hospital. To update the record, a doctor or other health care professional looks at the new medications prescribed in the hospital and compares them with the other medications the patient takes. |

| <ul style="list-style-type: none"> Documentation in the discharge summary that the discharge medications were reconciled with the most recent medication list in the outpatient medical record. There must be evidence that the discharge summary was filed in the outpatient chart on the date of discharge through 30 days after discharge (31 total days). Notation that no medications were prescribed or ordered upon discharge |

| <ul style="list-style-type: none"> Ensure MRP is completed within 30 days of every patient’s discharge. State which medications need to be continued, which medications need to be discontinued, and which medications need to be started. Completed after discharge date and record in outpatient medical record. |
